### **Read this first**

## Rules

Rules are used to react to events within a scene and trigger actions. To manage the rules active on the camera, open the camera's "SETUP" and go to MEGApix Ai > RULES.

Note: Chrome browser is recommended for Ai configuration.



The rules feature displays a live view from the camera and allows you to add, modify or delete rules.

### Show Burnt-in annotation for setup:

Enable or disable the active rules display on the camera's preview screen. This is for the setup only. To enable the burnt-in annotation on the camera's live and recorded view, go to MEGApix Ai> Burnt-In annotation on the left navigation bar.

Note: Burnt-in annotation to be enabled on the left navigation bar to be enabled here.

### **Rules:**

The table shows the current rules set up for the camera.

### Add, Modify, Delete:

When selected, the drop-down menu will display all available rules to add to the camera.

### How to Add a Rule:

1. Click 'Add' to display the available rules in the drop-down window, and select a rule to add.



- 2. Adjust the rule settings accordingly.
- 3. Click on 'Save' to save the rule.

### How to Modify a Rule:

- 1. Select a rule from the table.
- 2. Click on 'Modify' to open the settings for the rule and modify them accordingly.
- 3. Click on 'Save' to save the rule.

### How to Delete a Rule:

- 1. Select a rule from the table.
- 2. Click on 'Delete' to delete the rule from the list.

Note: Rules cannot be deleted if linked to an action or counter. Remove any links before deleting a rule.



## **Rules and Definitions**

The table will show the rules defined for the camera. Add can be used to add additional rules. Modify is used to change the settings on a selected rule, and Delete will remove the selected rule.

**Note**: Rules cannot be deleted if linked to an action or counter. Remove these links before attempting to delete them.

### Types of Rules Available

- Intrusion: When people or objects are first detected inside the detection zone, they trigger an alarm. The people or objects keep being tracked while in the detection zone.
- Line Crossing: When people or objects cross the detection line in any direction, they trigger an alarm. The people or objects are tracked only once when they cross the detection line.
- Enter: An alarm is triggered when people or objects overlap with the detection zone's border.
- Exit: An alarm is triggered when people or objects leave the detection zone.
- **Appear**: An alarm will be triggered when the camera tracks people or objects inside the detection zone. The rule detects people or objects being tracked from within the detection zone.
- **Disappear**: An alarm will be triggered when the camera stops tracking people or objects inside the detection zone. The rule detects people or objects that stop being tracked from within the detection zone.
- **Stopped**: An alarm will be triggered when people or objects cross into a detection zone and remain past the set dwell time. The people or objects must remain stopped. Use the dwell rule for alarm triggers when an object remains moving in the zone.
- **Dwell**: An alarm will be triggered when people or objects cross into a detection zone and remain past the set dwell time. The people or objects must stay moving. Use the Stopped rule for alarm triggers when an object remains stopped in the zone.
- **Direction**: When people or objects cross the direct line from the set direction and angle, they will trigger an alarm.
- **Tailgating**: Detect a person or object crossing the detection line within a set period from the previous people or objects that have passed through the detection zone.
- **Counting Line**: When a person or object crosses the detection line in the set "forward" direction, the count adds 1. When a person or object crosses the detection line, the count decreases by 1. The counting can be added as a text overlay on the camera's view.
- Logical Rules: The logical rules option combines rules to form a complex filter for events to check against, which can help reduce false alerts.
- Non-Detect Zone: The non-detect zone option can be used to exclude areas of the scene from being processed through the analytics engine. This can reduce false triggers caused by moving foliage or busy scenes.
- Camera Tampering: An alarm is triggered when the camera detects the camera's bagging, defocusing, and general movement. (Please note the camera tampering setup is completed under MEGApix Ai> TAMPER.)



The Intrusion rule triggers an event when an object is first detected in the detection zone.

Note: The Intrusion rule will trigger in the same circumstances as the Enter and Appear rules. The choice of which rule is most appropriate will depend on the scenario and the camera's FOV.

## Line Crossing

The line-crossing rule triggers an event when an object is first detected crossing the rule line. **Note**: The line-crossing rule will activate in the same circumstances as the direction and counting line rules. The choice of which rule is most appropriate will depend on the scenario and the camera's FOV.

The line's orientation and length can be reshaped by selecting the color nodes at the edge of the lines. Click on a gray node to split the segment and create a more complex shape. Select the minus red sign next to a node to remove a segment.

- 1. Name: Name the rule.
- 2. **Object Filter**: Allow the rule to trigger based on the classification of an object (e.g., person, vehicle). Any combination of the available options is possible.
- 3. **Event Actions**: Define the action to occur when an event is triggered. Any combination of the available options is possible.
  - a. TCP Event: Enable/disable TCP notification when an event occurs.
  - b. HTTP Event: Enable/disable HTTP notification when an event occurs.

If the zones used in rules for a double-knock scenario are in different locations, you can set an object's time threshold before triggering the following rule to become an event.



### How to create a logical rule:

- 3. Define a name for the rule.

  - b. **Mid-bottom:** The detection point for each person is located along the bottom line of the bounding box in the center.
- 4. Others:
  - a. Centroid: The detection point for each object is located in the middle of the bounding box.
  - b. **Mid-bottom:** The detection point for each object is located along the bottom line of the bounding box in the center.
  - c. Detection Confidence Threshold
- 5. Minimum threshold: Defines the confidence (as a percentage) required to start tracking the object.
- 6. Initial Tracking Threshold: Defines the tracking (as a percentage) required to trigger an event.
- 7. Click Apply to save the current settings.
- 8. Click **Clean up** to perform a clean-up process.



A license is required to take advantage of the MEGApix Ai video analytic features. DW's MEGApix Ai cameras come with the Ai license preloaded and activated at no extra cost.

In some cases, activation may be necessary to enable additional functionality.

An activation code is linked to the camera's hardware configuration and is not transferable.

To manage activation codes, navigate to the license menu from the MEGApix Ai setup category.

### **Activate License**

Activation Type: Defines the method that will be used for your activation request.

- Token: Allows the activation token to be entered to apply for further licenses.
- **Pre-activation:** Defines that software has been pre-licensed and no further action is required.
- Activation code: Provides the HW GUID to apply for further licenses.
  - **HW GUID:** The unique hardware code for this device. This is required to generate an activation code.
  - Activation code: This is where you enter activation codes to apply for licenses and enable features of the MEGApix Ai plug-in.

Note: Please refer to your license distributor for additional licenses.

### **Activated License(s)**

This provides a list of the installed licenses with the option of deleting highlighted licenses. Note: Multiple licenses can be applied to a camera, but only one can be active at a given time.

### Assign

Assign the selected license for use with analytics.



Note: The system will reload to reflect any changes the license has applied. This may result in features not being available.

## How to apply a Token

- Request an activation token from your DW distributor.
   If needed, send your DW distributor your camera's **HWCODE**.
- Click **Assign** and type or paste the activation token. Select **Activate**.
- Verify the license has been applied by confirming it is valid in the activated license(s) section.

## How to Delete License(s)

- Highlight the license you would like to delete.
- Select **Delete** and confirm the action to delete the license.

**Note**: deleting the active license from the camera will remove all analytic features. Any configured rules will be available when a new valid license is applied.



Tokens are used with event actions such as TCP and HTTP notifications. They are automatically filled in with the metadata for the event. This allows the event's details to be specified in the message, such as the location of the object, type of event, etc.

List of tokens: Below is a list of the available tokens and a description of the data they provide.

{{name}} – The name of the event.

 $\{\{id\}\}\)$  – The unique ID of the event.

{{type}} – The type of event. This is usually the type of rule that triggered the event.

{{status}} – The status of the event.

{{iso8601}} – The event time in ISO 8601 format. For example: Start time (ISO 8601 format): {{iso8601}} Start time (ISO 8601 format): 2017-04-21T10:09:42+00:00

{{time}} – The event time in Unix timestamp format. For example: time: {{time}} time: 1582308244.376

 $\{\{ip\}\}\)$  – The IP address of the device.

{{host}} – The hostname of the device.

{{datetime}} – The event time in the format DD MM D HH:MM:SS YYYY 'Tue Jan 1 12:00:00 2019'. for example: time: {{datetime}} time: Tue Jan 1 12:00:00 2019

{{zoneid}} – The zone ID of the event.

{{ruleid}} – The rule ID of the event.

{{bb}} – The bounding box of the object.

{{objectclass}} – The object class of the object triggering the rule.

{{mac}} – The MAC address of the device.
